Information about the Enrolment Form.

Please Read This Notice Before Completing The Enrolment Form.

This confidential enrolment form asks for personal information about your child as well as family members and others that provide care for your child. The main purpose for collecting this information is so that we can register your child and allocate staff and resources to provide for their educational and support needs. All staff at Springvale Rise Primary School and the Department of Education & Training are required by law to protect the information provided by this enrolment form.

Health information is collected so that staff can properly care for your child. This includes information about any medical condition or disability your child may have, medication your child may rely on while at school, any known allergies and contact details of your child's doctor. Springvale Rise Primary School depends on you to provide all relevant health information because withholding some health information may put your child's health at risk.

Springvale Rise Primary School requires information about all parents, guardians or carers so that we can take account of family arrangements. Family Court Orders setting out any access restrictions and parenting plans should be made available to Springvale Rise Primary School. Please tell us as soon as possible about any changes to these arrangements. Please do not hesitate to contact the Campus Principal or Principal, if you would like to discuss, in strict confidence, any matters relating to family arrangements.

Protecting your Privacy and Sharing and Information

The information about your child and family collected through this Enrolment Form will only be shared with school staff who need to know to enable our school to educate or support your child, or to fulfil legal obligations including duty of care, anti-discrimination law and occupational health and safety law. The information collected will not be disclosed beyond the Department of Education and Training without your consent, unless such disclosure is lawful.

Our school's use of online tools (including apps and other software) to collect and manage information

Our school may use online tools, such as apps and other software, to collect and manage information about your child. When our school uses these online tools, we do our best to ensure that your child's information is secure. These online tools enable our school to efficiently and effectively manage important information about your child and also to communicate with you. If you have any concerns about the use of these online tools, please contact us.

Emergency Contacts

Student Background Information

All of this information is kept strictly confidential and the Department will not otherwise disclose the information to others without your consent or as required by law.

Immunisation Status

This assists us in managing health risks for children. This information may also be passed to the Department of Human Services to assess immunisation rates in Victoria. Information sent to the Department of Human Services is aggregate data so no individual is identified.

Visa Status

This information is required to enable Springvale Rise Primary School to process your child's enrolment. Please provide a copy of their visa.

Updating Your Child's Records

Please let us know if any information needs to be changed by sending updated information to the school office. During your child's time with Springvale Rise Primary School we will also send you copies of enrolment information held by us. Please use this opportunity to let us know of any changes.

Access to Your Child's Record held by School

We will advise you if this is required and tell you how you can do this.
